The Board entered into Executive Session at 7:00 p.m.

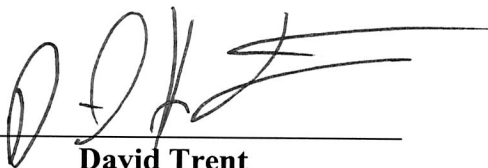
The Board returned to Open Session at 8:55 p.m.
