Board Chair David Trent called the regular meeting to order at 6:00 p.m. in the Board Room at the Genesis Education Center and welcomed everyone to the meeting. Trustee Dr. Lee Vartanian resigned from the Board as of May 1, 2020.

Superintendent's Report:

Superintendent Dr. Steve Glenn discussed the following:

- Updated the Board on the coronavirus and plans for the District.

Assistant Superintendent for Administration Mr. Gerald Witt presented the 2020-2021 Student Rights and Responsibilities for first reading. Mr. Witt responded to questions from the Board.

Assistant Superintendent for Business Mr. Rodney Smith gave a FY20 financial update for the District. He stated that 76 percent of the budget has been expended as of April 30, 2020.

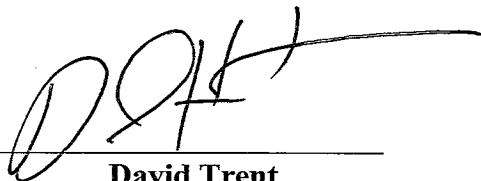

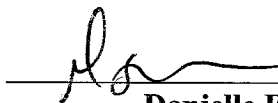
The meeting adjourned at 6:55 p.m.
